Our History and Mission

"To advocate for and provide the resources, skills, and shelter to alleviate abuse through prevention and intervention for all children and their families."

Manatee Children's Services was founded in 1977 by Carol Chamberlain: a librarian, teacher, and social worker with a passion for child advocacy. Through her work in social services, Carol learned that Manatee County had a dire need for shelter to house abused children removed from their homes. She rallied a group of citizens to make the shelter a reality and, to this day, MCS continues to operate as Manatee County's only emergency shelter for child victims of abuse and the county's only Child Advocacy Center.

We provide a full spectrum of programs serving over 12,000 children and families annually. We offer programs in treatment, prevention, intervention, and residential services. Such programs include an emergency shelter, long-term group homes, mental health services, parenting education and training, forensic medical and specialized child victim interview services, support services for relative caregivers, teen pregnancy prevention, and children's personal safety. 


MCS IN THE COMMUNITY

When abuse is reported, our Child Protection Team intervenes by providing medical exams and non-leading interviews with children to determine the next steps. Naturally, these children face lots of fear and uncertainty, so our CPT Advocates work hard to make them feel comfortable, safe, and heard.

"The amount of gratitude I receive from families for just reaching out with a listening ear and encouragement in reaching their goals is overwhelming," MCS Advocate Lucille Eisenhard said. "There can be a lot of chaos during this time in their lives. Some clients have told me they would have no idea where to start in helping their child if we hadn't been there to make sense of it all with them."
