Our History and Mission

"To advocate for and provide the resources, skills, and shelter to alleviate abuse through prevention and intervention for all children and their families."

Manatee Children's Services was founded in 1977 by Carol Chamberlain: a librarian, teacher, and social worker with a passion for child advocacy. Through her work in social services, Carol learned that Manatee County had a dire need for shelter to house abused children removed from their homes. She rallied a group of citizens to make the shelter a reality and, to this day, MCS continues to operate as Manatee County's only emergency shelter for child victims of abuse and the county's only Child Advocacy Center.

We provide a full spectrum of programs serving over 12,000 children and families annually. We offer programs in treatment, prevention, intervention, and residential services. Such programs include an emergency shelter, long-term group homes, mental health services, parenting education and training, forensic medical and specialized child victim interview services, support services for relative caregivers, teen pregnancy prevention, and children's personal safety. COMMUNITY NEWS



MCS is the proud recipient of a \$42,177.00 grant from NCA for evidence-based therapy to children impacted by trauma from abuse, as well as their families. The program will assist with decreasing trauma symptoms such as depression and anxiety, understanding and reporting abuse, establishing boundaries, developing coping strategies, and learning how to protect themselves against future threats to safety.

In the past ten years, population growth in Florida has affected Manatee County significantly, resulting in a 20% increase of new residents. This growth has increased the demand for clinical services to our county's child abuse victims. MCS is the only Child Advocacy Center in Manatee County and one of only three facilities in the region that provide specialized therapeutic treatment for child abuse victims and their families. Currently, all three facilities have a waitlist for clinical services that address the effects of child abuse. The NCA grant funding will allow us to continue and expand our essential services to meet this crucial community need.

COMMUNITY SPOTLIGHT

Chuck & Ann Marie Shields

MCS PROGRAM SPOTLIGHT



Because of your support, our programs are able to continue breaking the cycle of child abuse for victims and families.

KIDS Personal Safety served 13,955 children in Manatee County last year. The program delivers three 50-minute classroom presentations to elementary schoolchildren in Manatee County utilizing the evidence-based "Monique Burr" curriculum. These presentations aim to educate children about personal safety threats, focusing on child abuse and bullying. In addition to providing knowledge about these issues, the program empowers children to report potential threats to their safety at a level suitable for their age. Following each presentation, students participate in a brief post-test to recall information they have gained about personal safety, assessing their understanding and the material's effectiveness.

Most importantly, the post-test includes a section allowing children to express their desire to speak privately with the Personal Safety Instructor. In the event of a disclosure of child abuse during this private meeting, the instructor evaluates whether there is reasonable cause to suspect abuse, abandonment, or neglect by the parent or caregiver, subsequently reporting to the state child abuse hotline as mandated by Florida Statutes. If a child discloses bullying, the guidance counselor is informed to collaborate with the child and ensure the cessation of bullying. Children are informed during disclosure about the actions the Personal Safety Instructor will take to assist them, assuring them that a trusted adult will intervene to ensure their safety and put an end to any abuse.

KIDS Personal Safety has also successfully implemented a fully bilingual instructor, enabling effective communication and support for children who aren't proficient in English. We are so grateful for our KIDS staff members' hard work in helping to break the cycle of abuse.
