### **Our History and Mission**

"To advocate for and provide the resources, skills, and shelter to alleviate abuse through prevention and intervention for all children and their families."

Manatee Children's Services was founded in 1977 by Carol Chamberlain: a librarian, teacher, and social worker with a passion for child advocacy. Through her work in social services, Carol learned that Manatee County had a dire need for shelter to house abused children removed from their homes. She rallied a group of citizens to make the shelter a reality and, to this day, MCS continues to operate as Manatee County's only emergency shelter for child victims of abuse and the county's only Child Advocacy Center.

We provide a full spectrum of programs serving over 12,000 children and families annually. We offer programs in treatment, prevention, intervention, and residential services. Such programs include an emergency shelter, long-term group homes, mental health services, parenting education and training, forensic medical and specialized child victim interview services, support services for relative caregivers, teen pregnancy prevention, and children's personal safety. # **COMMUNITY SPOTLICHT**



This month's Community Spotlight shines on Suli Law, a dedicated team led by partners Laura Sulisufay and Kelli Martinez. Combining expertise from insurance defense and personal injury, they've built a powerhouse firm of attorneys, case managers, and paralegals advocating for injury victims and homeowners in insurance claims and litigation.

Attorney Kelli Martinez, a committed children's advocate, serves on the MCS Board of Directors and mentors high school students through Take Stock in Children. Suli Law also actively supports local charities, including the Women's Council of Realtors Fashion Show and the LECOM Suncoast Classic for Sertoma Kids. Kelli stated our community has a crucial need for mentors and resources for children to inspire leadership and entrepreneurship.

When asked why she chose to serve on our Board of Directors, Kelli shared her admiration for our integrated approach to intervention, education, prevention, and support services.

"The holistic collaboration of services provides youth in need with a smoother, better focused transition and prompt access to services," Kelli said.





Our residential staff work vigilantly to help the foster children in our group homes attain independent skills necessary to become successful adults.

"Nicole" entered care as a toddler and was adopted during elementary school. However, at 16, her adoptive parents returned her to foster care, and she came to live in the MCS group home. It took time for Nicole to adjust, as she initially struggled with outbursts and found it difficult to open up. Over time, though, she began to trust the MCS team and learned to communicate her feelings more effectively. With staff support, Nicole took steps toward independence, including earning her learner's permit, taking driving lessons, and opening a bank account.

At 17, Nicole found a job and excelled in school. Despite occasional challenges, she worked with a tutor and graduated at 17, before aging out of the system. While still in care, she was accepted to State College of Florida, where she began coursework toward a degree in criminal profiling. When Nicole turned 18, she chose to enter extended foster care and secured an apartment.

Nicole's journey has been full of ups and downs, but she persevered, and MCS is incredibly proud of her achievements. We look forward to seeing all she accomplishes in the future.
