Our History and Mission

"To advocate for and provide the resources, skills, and shelter to alleviate abuse through prevention and intervention for all children and their families."

Manatee Children's Services was founded in 1977 by Carol Chamberlain: a librarian, teacher, and social worker with a passion for child advocacy. Through her work in social services, Carol learned that Manatee County had a dire need for shelter to house abused children removed from their homes. She rallied a group of citizens to make the shelter a reality and, to this day, MCS continues to operate as Manatee County's only emergency shelter for child victims of abuse and the county's only Child Advocacy Center.

We provide a full spectrum of programs serving over 12,000 children and families annually. We offer programs in treatment, prevention, intervention, and residential services. Such programs include an emergency shelter, long-term group homes, mental health services, parenting education and training, forensic medical and specialized child victim interview services, support services for relative caregivers, teen pregnancy prevention, and children's personal safety. 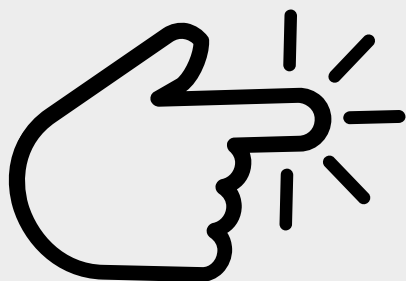

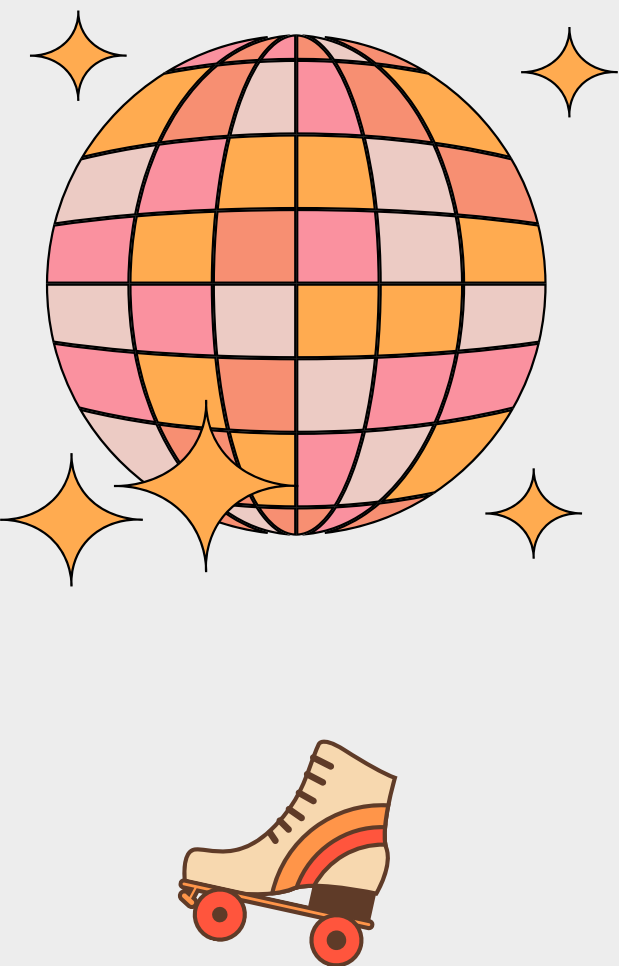

AGENCY SUCCESS STORIES



Our Spanish-speaking Non-Offending Caregiver (NOC) group therapy sessions provide a safe and supportive space for caregivers of children who have experienced sexual abuse. These groups help families navigate the aftermath of abuse, strengthen their capacity to support their children, and create personalized safety plans to prevent future harm.

One caregiver reflected: “The NOC support group gave me the power to work with my children and be able to speak with them about the abuse. I want to practice all the learning to prevent future incidents. I advise other parents to be informed about those topics, not only when something like that happens. I think these classes must be part of our education as parents to prevent sexual abuse in our children.”

For many Hispanic and Latinx families, cultural and language barriers often make it difficult to access the help they need. By offering groups in Spanish and tailoring them to be culturally sensitive, we are breaking down barriers and ensuring every family has access to healing, education, and support. Testimonials like these remind us why expanding access to culturally responsive therapy is vital — because no family should ever have to walk this journey alone.
